#### 1. Introduction

Arupa Limited (In Liquidation) ("the Company") was placed into liquidation by order of the High Court at Rotorua on the 16<sup>th</sup> day of June 2008 at 10.56am. Kenneth Peter Brown and Robert James Neilson, both Chartered Accountants of Tauranga, were appointed as Joint and Several Liquidators of the company. Robert Neilson passed away on 25<sup>th</sup> December 2013. Accordingly, Kenneth Brown remained as the sole liquidator.

In accordance with section 257 of the Act, we are obliged to report to all creditors and shareholders that the liquidation has been completed. This report should be read in conjunction with our previous report pursuant to section 255 (2) of the Act.

#### 2. Restrictions

This report is not intended for general circulation, nor is it to be reproduced or used for any purpose other than that outlined above without our written permission in each specific instance.

We do not assume any responsibility or liability for any losses occasioned to any party as a result of the circulation, publication, reproduction or use of this report contrary to the provisions of this paragraph.

We reserve the right (but will be under no obligation) to review this report and if we consider it necessary to revise the report in the light of any information existing at the date of this report which becomes known to us after that date.

#### 3. Statement of Realisation and Distribution

#### 4. Liquidators' Statement

All known assets have been disclaimed, realised or distributed without realisation.

All proceeds of realisation have been distributed.

The Company is ready to be removed from the New Zealand Register of Companies.

#### 5. Removal from New Zealand Register of Companies

The Liquidator is obliged to give public notice of the intention to have the Company removed from the Register of Companies. A copy of his notice is attached as **Appendix 2**.

The attention of all creditors and shareholders is drawn to section 321 of the Act which provides that, where public notice is given of an intention to remove a company from the Register, any person may send or deliver to the Registrar, not later than the date specified in the notice, an objection to the removal on any one or more of the following grounds:

(a) That the company is still carrying on business or there is other reason for it to continue in existence; or



- (b) That the company is party to legal proceedings; or
- (c) That the company is in Receivership, or Liquidation, or both; or
- (d) That the person is a creditor, or a shareholder, or a person who has an undischarged claim against the company; or
- (e) That the person believes that there exists, and intends to pursue, a right of action on behalf of the company under Part IX of this Act; or
- (f) That for any other reason, it would not be just and equitable to remove the company from the New Zealand register.

Creditors and shareholders should be aware of section 321(2)(b)(ii) of the Act which provides that a claim by a shareholder or any other person against a company is not an "undischarged claim" if a receiver or liquidator has notified the shareholder or that person that the company has no surplus assets.
