Course Overview

Finance & Accounting Fundamentals is a one-day breakthrough introductory finance workshop delivering unprecedented financial literacy to underpin business acumen. It uses a different and fresh approach called the Color Accounting Learning System.

It shows how accounting, finance and business work, and importantly, how they interrelate. Participants leave able to read a balance sheet and income statement, telling a meaningful financial story that informs decision-making.

HOW IT WORKS

The workshop uses a visual and hands-on approach which has participants discover the five essential finance concepts everyone should know. 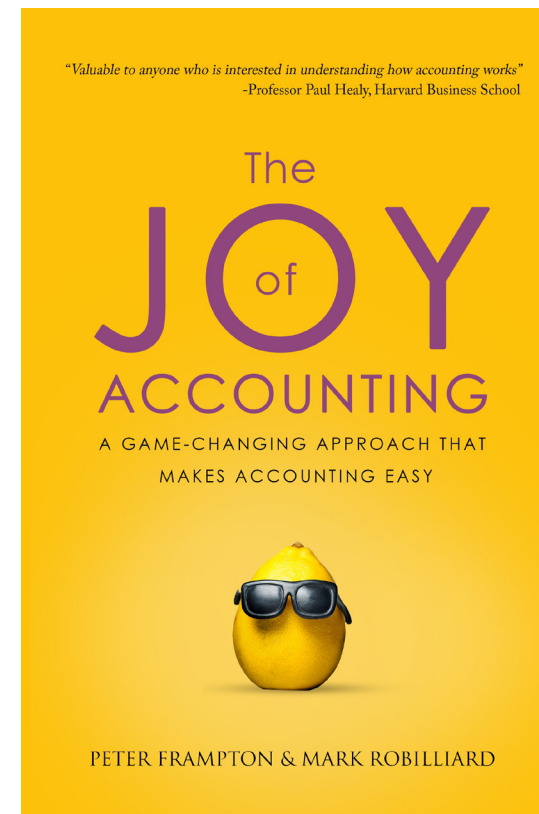
